#### ORDER

## New Delhi, the 4<sup>th</sup> August 2010

No. 6(6)/2010-CLF&E.— Whereas under the notification of the Government of India, Ministry of Communications and Information Technology (Department of Information Technology) vide No. G.S.R. 630(E) dated 26<sup>th</sup> July 2010 issued under sub-section (1) of section 70 of the Information Technology Act, 2000 (21 of 2000), (herein referred to as "the said Act"), the Central Government has declared the TETRA Secured Communication System Network, its hardware and software to be a protected system;

And whereas it is necessary to authorize certain persons under sub-section (2) of section 70 of the said Act to access protected systems notified under the said notification;

Now, therefore, in pursuance of sub-section (2) of section 70 of the said Act, the Central Government hereby authorizes the persons mentioned in the Schedule given below to access the protected system.

#### SCHEDULE

- 1. Officers to be designated by the Central Government
- 2. Officers to be designated by the Government of NCT of Delhi
- 3. Officers to be designated by M/S HCL Infosystems Limited
- 4. Officers to be designated by M/S Motorola India Private Limited
- 5. Officers to be designated by M/S Telecommunication Consultants India Limited.
